## **ORDINANCE 2007-9**

## AN ORDINANCE TO SETTLE PENDING LITIGATION

WHEREAS, the Town of Colfax, Indiana, intends to protect the Town in all pending and future litigation;

WHEREAS, the Town has been sued and may be sued in the future; and

WHEREAS, the Town through its officers and representatives, have agreed to settle pending litigation by amending the Town Code in two (2) places as set forth below.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF COLFAX, INDIANA, that:

Section 1: The Town Code, presently being revised, also be modified, in all appropriate places, to reduce the allowed maximum grass height in the Town from eleven (11) inches to eight (8) inches.

Section 2: Any individual cited for violation of the Municipal Code of the Town of Colfax, will have up to ten (10) working days to pay their fine at the Town Clerk-Treasurer's office. Failure to pay the fine within ten (10) working days will result in the citation being filed with the clerk of the Superior Court of Clinton County to be disposed on the assigned trial date. Cited individuals shall also have a right to request an appearance before the Town Council to request a reduction or elimination of any fine.

Section 3: There being an emergency for the protection of the public health, this Ordinance is effective on passage.
